Ms. Noah asked about 7 norms of collaboration (Pausing before responding or asking a question allows time for thinking and enhances dialogue, discussion, and decision-making. Questions may be posed to explore perceptions, assumptions, and interpretations, and to invite others to inquire into their thinking) and whether it would be appropriate to ask students how they are socio-emotionally. Ms. Noah recommended putting in words about having parents checking in with students about their day at school.
